# Article 1 – Boys Baseball

## CONFERENCE BOYS BASEBALL COMMUNICATION

### Section 1 – Website

The East Suburban Catholic Conference maintains a website specifically dedicated to information, activities, results, and archives as they relate to the Conference events.

### Section 3 – Meetings

The East Suburban Catholic Conference has scheduled meetings throughout the school year to facilitate the operation of the Conference and its activities.

The specific sport resource Athletic Director may conduct a preseason meeting as deemed necessary and appropriate.

Each school is required to present a knowledgeable representative to all scheduled meetings.

It is expected that the head coach of each conference school would make every effort to attend.

In the event there is a need to send a substitute, it is expected that the head coach will prepare the designee with necessary agenda and information so that each school will be represented in a positive manner.

### Section 4 – All Conference Selection Meeting

The boys Baseball All Conference and post season meeting is scheduled for Sunday, May 20, 2018.

Contacts for this meeting are to be made by the Conference Secretary.

The meeting will be held at St Patrick High School and begin at 10:00 a.m.

For coaches (or representative) missing this meeting: first year probation status; second year: no all-conference selections.

### Section 5 – Results And Statistics

The East Suburban Catholic Conference has designated Kevin Kelly (Marian Catholic) as the Conference Statistician.

Official team standings and game results will be kept in boys Baseball for the freshman, sophomore, and varsity levels of competition.

Team standings and game results will be posted on the East Suburban Catholic Conference website and will be updated as results become available through the Conference Statistician.

It is the responsibility of each head coach at the freshman, sophomore, and varsity level to FAX or email each game result to the Conference Statistician at the conclusion of each contested event.

Special forms have been prepared for the reporting of results to the Conference Statistician. They can be found on the East Suburban Catholic Conference website.

Results should be FAX or emailed immediately. If a contest has been cancelled or rescheduled, it is the responsibility of each head coach at the freshman, sophomore, and varsity level to identify that information to the Conference Statistician.

## CONFERENCE BOYS BASEBALL ADMINISTRATION

### Section 6 – Scheduling

Scheduling of boys Baseball will be done by the Athletic Directors or their designees.

The Chairperson of the East Suburban Catholic Conference Athletic Directors will prepare a Master Contract that will contain all conference schedules for the succeeding year.

The Master Contract will be signed by the Principal and Athletic Director of each member school at the May Board of Control Meeting.

There will be a double round robin schedule for freshman, sophomore, and varsity teams.

The freshman and sophomore contests will be scheduled on the same day and time at the opposite site of the scheduled varsity opponent.

No East Suburban Catholic Conference game can be scheduled before the first Saturday of the conference season, which is the Saturday of Week 41 of the Illinois High School Association calendar.

If a game has to be changed due to an academic requirement, the game should be rescheduled as close to the original scheduled date as possible.

### **Section 7 - Eligibility**

The Rules of Eligibility of the Illinois High School Association shall apply.

Freshman level competition in boys Baseball shall be limited to students in their first two semesters after entering the ninth (9<sup>th</sup>) grade.

Sophomore level competition in boys Baseball shall be limited to students in their first four semesters after entering the ninth (9<sup>th</sup>) grade.

Varsity level competition in boys Baseball may include students in the freshman, sophomore, junior, or senior years of school unless individual operating procedures designate otherwise.

A player (contestant) in boys Baseball may not compete against a single school in more than two total contests per conference scheduling period.

### **Section 8 - Starting Times**

The recommended starting time is 04:30 pm for all Baseball competition on weekdays.

The recommended starting time is 10:00 am for all Baseball competition on Saturdays.

A maximum 20-minute warm-up will be instituted for late-arriving teams, beginning from the time that all athletes have arrived in the dugout.

### **Section 9 - Officials**

Two Illinois High School Association umpires are to be contracted for a varsity boys Baseball contest.

If only one umpire is available, the contest is to be played.

It is recommended that two Illinois High School Association umpires are to be contracted for the freshman and sophomore boys Baseball contests.

If only one umpire is available, the contest is to be played.

The home team for the contest will pay for the officials regardless of the original site location.

### **Section 10 - School Information**

All Conference schools shall furnish the following information to the other schools at least one week prior to their scheduled varsity game.

Boys Baseball Information Sheet (as prepared by individual schools)

- Name of school,
- Name of principal,
- Name of athletic director,
- Names of varsity coaches,
- School colors;
- School nickname,
- Names of trainers and managers,
- Name of team physician.

Boys Baseball Roster (s) for all levels of competition (as prepared by individual school)

- Numbers (arranged numerically according to away jersey numbers);
- Names;
- Positions;
- Year In School;
- Height;
- Weight.

Any changes in players' numbers that may occur after the original roster (s) has been supplied should be corrected by the head coach to the opposing head coach and to the announcer prior to the start of the contest.

## **CONFERENCE BOYS BASEBALL HONORS**

### **Section 11 - Championships**

Championships in freshman, sophomore, and varsity Baseball will be determined on a percentage basis. In the event of a tie, co-championships will be recognized.

### **Section 12 – Team Awards**

A plaque will be awarded every year to the team champions or co-champions at the varsity level according to the Conference standings.

### **Section 13 - All-Conference**

An all-conference squad will be selected in Baseball by vote of the head coaches of each member school. The number in Baseball will be **thirty-two (32)**.

Certificates of Honor will be presented to an All-Conference team, as determined by the vote of the coaches of all member schools participating in Baseball.

Certificates will be prepared and awarded to the schools by the secretary. The number of certificates awarded for Baseball shall be determined by the Athletic Directors and has been set at **thirty-two (32)**.

Selection of All-Conference players will be done at the special meeting held immediately after the championship is determined.

The Baseball All Conference and post season meeting is scheduled for Sunday, May 20, 2018.

Contacts for this meeting are to be made by the Conference Secretary.

The meeting will be held at St Patrick High School and will begin at 10:00 am.

The Conference Secretary is responsible to publish the boys Baseball All Conference team.

There will be a copy of the boys Baseball All Conference team published on the East Suburban Catholic Conference website.

The Conference does not recognize Honorable Mention teams and will not publish or recognize any such selections.

#### **Section 14 – Special Post Season Conference Awards**

Excellence in boys Baseball will be recognized with the selection of a Player of the Year and a Coach of the year.

The Player of the Year of the Conference in boys Baseball will be the individual that receives the highest number of votes after nomination.

The Coach of the Year of the Conference in boys Baseball will be the individual that receives the highest number of votes after nomination.

A specially designed Conference Certificate of Honor will be presented to the Player of the Year and Coach of the Year in boys Baseball.

### **CONFERENCE BOYS BASEBALL SPECIFIC RULES**

#### **Section 15 - Game Ball**

Any official top grade baseball is to be used with a minimum of three baseballs per game. A National or American League baseball is recommended.

#### **Section 16 - Special Regulations**

The ten run rule is mandatory in all contests.

The re-entry rule and the use of a courtesy runner for the pitcher and catcher shall follow state rules.

#### **Section 17 - Incomplete Contests**

Any contest on all levels that is suspended for any reason shall be considered an official regulation (complete) game if the losing team has had an opportunity to hit for five full innings. If both teams have not had an equal opportunity to hit after five innings, the contest will revert to the last full completed inning. Exception: the home team has taken the lead in a partially-completed inning in the fifth inning or beyond (declared winner).

Any game that is not an official regulation game (four and one-half innings if the home team is ahead or five innings if the visiting team is ahead) will be considered a suspended game and shall be continued from the point of suspension.

All varsity tie contests that are official regulation games will be continued at the point where the game was suspended at the same site (or by agreement) on the first open date.

Sophomore and freshman official regulation tie contests will be determined on a .5 won and .5 loss basis in the standings and will not be replayed.

#### **Section 18 - Postponed Contests**

The decision whether or not to play when weather and ground conditions are doubtful rest on the judgment of the host school.

Postponed contests are to be played the next day. If games are continually postponed, they are automatically rescheduled in the order of postponement as set by the Athletic Directors.

State Tournament contests take preference over regularly scheduled Conference contests.

Regularly scheduled or rescheduled Conference contests will always take preference over regularly scheduled or rescheduled non-conference contests.

Conference teams are required to complete their conference schedule, but if late, in season, continued postponements occur; these teams need not play when mutually agreed upon unless any contest has a bearing on the Conference Championship.

In the event the host field is unplayable and the visiting location is playable, the contest is to be played at the available field whenever possible.

The varsity contest will take priority over lower levels with both fields and umpires.

This is followed in the priority of the sophomore level and the freshman level.

If a contest is moved to the alternate site, the umpires scheduled for the lower level contest will be used on the varsity level, only if the scheduled umpires for the varsity contest cannot be moved to the new location, and if the lower level umpires are determined competent to handle varsity level competition. This decision will rest with the assignment chairman for that school and the Athletic Director.

This also applies to doubleheaders. In the event that both sites are not playable for a doubleheader, then the contests are to be made up in a doubleheader format at the site of the original host school or to be made up on individual days **with each school serving as host once.**

In the event a contest is moved to the visitor's site from the original site due to field availability or playing conditions, the schedule remains intact for remaining contests.

Varsity contests are to be played first with sophomore and freshman contests following in priority. Varsity contests are to be moved to the first available playing facility.

#### **Section 19 - Doubleheaders**

Doubleheaders will be scheduled in the East Suburban Catholic Conference. When a doubleheader is scheduled, each team will assume the role of the home team.

The host school will be the home team for the first game, and the visiting school will be the home team for the second game. The doubleheader host school will supply baseballs for the doubleheader.

Communication should take place concerning the amount of time between contests. It is recommended that fifteen (15) minutes be allowed for necessary adjustments between contests.

#### **Section 20 – Use of Extra Hitter**

Sophomore and Freshman levels may use an "extra hitter" as defined in addendum EH2012.

The sophomore and varsity will play at the site designated by the schedule.

The freshman will play at the same sites on Friday unless a second gym is not available (same site on Saturday or Monday).

The schedule shall be counted backwards from the Monday before the Illinois High School Association Regional Tournament.

### **Section 7 - Eligibility**

The Rules of Eligibility of the Illinois High School Association shall apply.

Freshman level competition in boys Basketball shall be limited to students in their first two semesters after entering the ninth (9<sup>th</sup>) grade.

Sophomore level competition in boys Basketball shall be limited to students in their first four semesters after entering the ninth (9<sup>th</sup>) grade.

Varsity level competition in boys Basketball may include students in the freshman, sophomore, junior, or senior years of school unless individual operating procedures designate otherwise.

No player may appear in more than six (06) quarters per scheduling period. The following criteria to be followed:

- one live ball equals one quarter;
- fourth quarter and overtime(s) are defined as one quarter;
- this move can only be made with players moving from a lower level to an upper level;
- player (s) must be identified prior to the contest.

Freshman players can play a total of four quarters in both the "A" and "B" games on a given day. The seven pre-designated "A" team players may not play in the "B" game.

### **Section 8 - Starting Times**

The recommended starting time is 05:30 pm for all sophomore boys' Basketball competition.

The recommended starting time is 07:00 pm for all varsity boys' Basketball competition.

The recommended starting time is 05:30 pm for all freshman boys' basketball competition on weekdays.

The recommended starting time is 10:00 am for all freshman boys' basketball competition on Saturday.

Pre-game warm-up time for men's Basketball for freshman A, sophomore, and varsity have been set at fifteen (15) minutes

### **Section 9 - Officials**

Three Illinois High School Association officials are to be contracted for a varsity boys Basketball contest.

Two Illinois High School Association officials are to be contracted for the freshman and sophomore boys Basketball contests.

### **Section 10 - School Information**

Selection of All-Conference players will be done at the special meeting held immediately after the championship is determined.

The boys Basketball meeting is scheduled for Saturday, February 24, 2018.

Contacts for this meeting are to be made by the Conference Secretary.

The meeting will be held at St Patrick High School and begin at 09:30 a.m.

The Conference Secretary is responsible to publish the boys Basketball All Conference team.

There will be a copy of the boys Basketball All Conference team published on the East Suburban Catholic Conference website.

The Conference does not recognize Honorable Mention teams and will not publish or recognize any such selections.

#### **Section 14 – Special Post Season Conference Awards**

### **CONFERENCE BOYS BASKETBALL SPECIFIC RULES**

#### **Section 15 - Length of Contests**

Length of quarters in freshman "A" and "B," and sophomore contests shall be seven minutes, and in junior varsity and varsity contests shall be eight minutes.

#### **Section 16 - Uniforms**

The home team shall wear light colored jerseys, and the visiting team shall wear dark colored jerseys.

#### **Section 17 - Game Ball**

The official Conference basketball will follow the State or Illinois High School Association regulations.

The host school at all levels of boys Basketball will be responsible for supplying boys basketballs to visiting schools for all warm up periods.

The host team at all levels shall provide the visiting team with a chalkboard or grease board with appropriate writing implements.

The host school at all levels of boys Basketball should supply the visiting team with water and a method to dispense the water.

#### **Section 18 - Extraordinary Assistants**

The timing, scoring, and announcing positions at sophomore and varsity boys Basketball contests will be handled by adults.

An adult is defined as a member of the school's staff, when possible, or as parents, responsible alumni, or capable associates, when the need arises.

Except for the above situation, no contestant shall compete on more than one level per conference scheduling period.

Freshmen are eligible to compete at the varsity level.

### **Section 8 - Starting Times**

Sophomore contests shall start at 05:00 pm for night contests and 11:00 am for day contests unless mutually agreed otherwise.

Varsity contests must begin at 07:30 pm for night contests and 01:30 pm for day contests, or twenty minutes after the completion of the sophomore game, whichever of these times is later.

The varsity warm up time between the sophomore and varsity contests shall be limited to twenty (20) minutes.

Ceremonies between halves shall be limited to fifteen (15) minutes, except homecoming ceremonies, which shall be limited to twenty (20) minutes.

### **Section 9 - Officials**

Five Illinois High School Association officials are to be contracted for a varsity boys Football contest.

Five Illinois High School Association officials are to be contracted for a sophomore boys Football contest.

Four Illinois High School Association officials are to be contracted for a freshman boys Football contest.

### **CONFERENCE BOYS FOOTBALL HONORS**

#### **Section 11 – Championships**

Championships in freshman, sophomore, and varsity boys Football will be determined on a percentage basis. In the event of a tie, co-championships will be recognized.

A team that does not play a full Conference schedule as approved by the Athletic Directors will not be considered for the championship.

The Conference representative to the State Playoffs will be the team with the victory over the other team if they played each other during the Conference season.

In the event of a tie in the Conference standings and the teams did not play, or a tie between three or more teams, there will be co-champions, but the conference representative to the State Playoffs will be decided using the at-large selection formula that is outlined in the Illinois High School Association Football rules and regulations.

### **CONFERENCE BOYS FOOTBALL SPECIFIC RULES**

#### **Section 15 - Length of Contests**

Freshman Football contests are to be played with ten-minute quarters.

Sophomore and Junior Varsity Football contests are to be played with ten-minute quarters.

Varsity Football contests are to be played with twelve-minute quarters.

#### **Section 16 - Uniform**

The home team shall wear dark or colored jerseys, while the visiting team shall wear white or light colored jerseys unless otherwise agreed upon.

#### **Section 17 - Game Ball**

There is no official conference football. It should be noted that the Illinois High School Association mandates the use of a Wilson football in all playoff Contests.

#### **Section 18 - Extraordinary Assistants**

Schools shall attempt to have a qualified doctor or medical personnel in attendance at sophomore and varsity boys Football contests.

The timing, scoring, and announcing positions at sophomore and varsity boys Football contests will be handled by adults.

An adult is defined as a member of the school's staff, when possible, or as parents, responsible alumni, or capable associates, when the need arises.

Exceptions to this would be if the home team rents the playing facility and has no control over the persons running the above positions.

The downs marker and chain crew should be trained adult personnel provided for the sophomore and varsity games by the home school.

The chain crew should operate the entire game from the side of the field opposite the press box.

#### **Section 19 - Incomplete Contests**

Varsity tie contests will be broken according to the accepted tiebreak plan as designated by the Illinois High School Association.

Junior varsity, sophomores and freshmen contests may end in a tie (no overtime will be played).

#### **Section 20 - Tie Break Method**

The method used to break ties and determine the Conference Champion will be as follows:

- Head to head competition result;
- Adding the total number of wins by all of the schools' opponents; the school with the most opponent wins will receive the berth;
- If there is still a tie, only the wins of each opponent beaten by the one or more than one tied team will be added, and the school with the most wins by a beaten opponent will receive the championship;
- Only the wins of each opponent to beat a tied team will be added, and the berth will go to the school having lost to the opponent (s) with the most wins;
- Should none of the previous steps determine the team to fill any remaining position (championship or at-large, the final step would be a flip of the coin arranged by the secretary of the Conference. (Determined: May 24, 1990)

(Approved: Board of Control - November, 1990).

#### **Section 21 – Football Film Exchange**

Coaches may ask for any three (3) films in the exchange. The only exception would be Week 3 exchange since only two films available.

Film must be wide view.

Scouts may not film at an opponent's game.

No exchanging ESCC games with nonconference opponents. Only exceptions would be exchanges with schools on your schedule or playoff opponents.

The place and time of the meet for the Conference championship will be determined by agreement of the Athletic Directors each year, and the designated tournament host school of the Conference by rotation will conduct the meet.

A rules committee composed of the local golf pro from the host course and two coaches will administer the meet.

It is recommended that one of the two coaches be from the host school of the meet, and the other coach be from next year's host school.

Ties for placement not involving first-, second-place or the final (16<sup>th</sup>) medal will be provided with duplicate medals.

In the case of individual ties at the Conference Championship Meet, the recommended USGA tie-breaker will be used. There will not be a playoff.

The number of contestants from each school entered in the varsity Conference Meet shall be a maximum of six (6).

The decision about playing when weather and ground conditions are doubtful rests on the judgment of the host school until the umpire takes charge of the contest. Postponed contests are to be played the next day, if possible.

If contests are continually postponed, the Athletic Directors should reschedule them in the order of postponement as set. State Tournament contests take preference over scheduled Conference contests.

Conference teams are required to complete their conference schedule, but if continued postponements are late in season, these teams need not play when mutually agreed upon unless any game has a bearing on the Conference Championship.

If a contest is moved to the alternate site, the umpires scheduled for the lower level contest will be used on the varsity level, only if the scheduled umpires for the varsity contest cannot be moved to the new location, and if the lower level umpires are determined competent to handle varsity level competition. This decision will rest with the assignment chairman for that school and the Athletic Director.

Dual meet scoring shall allow one point for each match won. These points will be used in the determination of the league standings.

The maximum number of points for dual match competition will be five times the number of teams competed against in the Conference (20 points).

The Singles Player of the Year and Doubles Team of the Year of the Conference in boys Tennis will be the individual/doubles team that receives the highest number of votes after nomination.

The Coach of the Year of the Conference in boys Tennis will be the individual that receives the highest number of votes after nomination.

A specially designed Conference Certificate of Honor will be presented to the Player of the Year and Coach of the Year in boys Tennis.

**CONFERENCE BOYS TENNIS SPECIFIC RULES**

**Section 14 - Regular Season Play**

Each Conference team will play a four-match round-robin in a North or South concept.

Each team will play two singles and three doubles matches on each level in the dual meets. These will be played on the same day at the same site.

If existing conditions dictate that a school not enters a full team for competition in a Conference dual meet, the opposing coach must be called at least one day prior to the match.

Dual conference matches will be scheduled on Tuesday and Thursday.

Rained-out matches must be rescheduled by the teams involved and should be played by the Wednesday before the East Suburban Catholic Conference Tennis tournament. If the match is not completed by Wednesday, both teams will be awarded zero (0) points for the contest.

A ten-minute warm up period is usual. All practice serves should be taken during this time.

The players will dress appropriately for Tennis play (according to the terms and conditions for boy's Tennis published by the Illinois High School Association).

Team line-ups should be exchanged before the match. The guiding rule will be: "make the team as strong as you can without moving anyone downward."

The Varsity and junior varsity will use regulation scoring and play the best two of three sets.

If a team arrives late and darkness becomes a factor, no – ad scoring will be used if both coaches agree.

If the score in a set reaches six all, the seven-point tiebreaker will be used.

The Illinois High School Association Point Penalty System will be in effect during all Conference matches and also during the Conference tournament. The home coach will give the warning before the match, or at the beginning of the tournament.

The Illinois High School Association policy on coaching will be in effect.

All other Illinois High School Association and United States Tennis Association rules, regulations, and guidelines will apply.

**Section 15 - East Suburban Catholic Conference Tennis Tournament**

The East Suburban Catholic Conference boys Tennis tournament will be held on the weekend before the Illinois High School Association boy's Sectional tournament

The place and time of the Conference Meet will be determined by agreement of the Athletic Directors each year.

The East Suburban Catholic Conference Tennis tournament will be set up with brackets for First and Second Singles, and First, Second, and Third Doubles. The seeding and draw for the junior varsity and varsity levels will be done on the Wednesday before the Conference tournament begins.

To be a top seed in the Conference tournament unless a vote by the coaches is taken:

At SINGLES (first or second)

A player must have played a minimum of three matches at that position in the dual matches all on the same level. (Junior varsity or varsity).

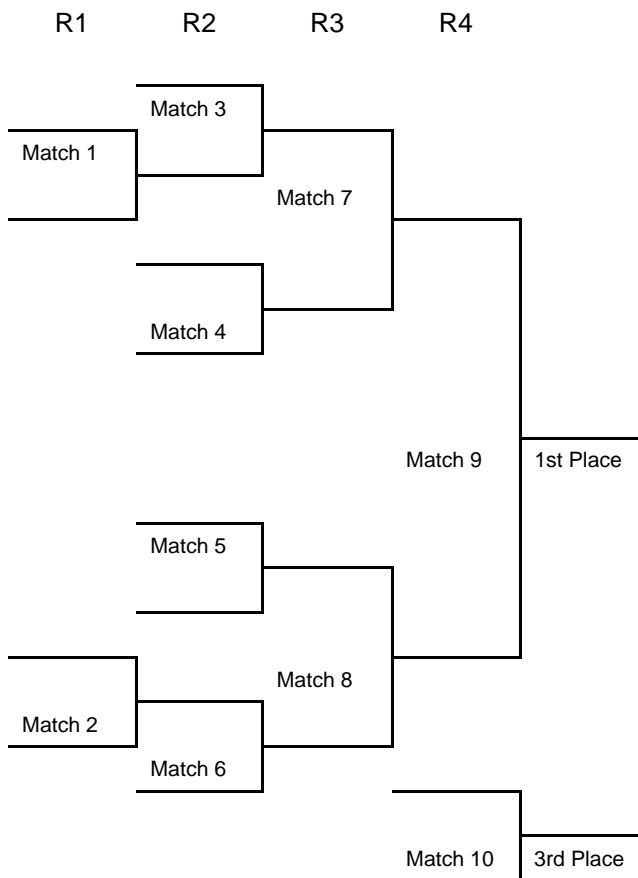
At DOUBLES (first or second)

Each team must consist of two players that have played a minimum of three matches at that position (as a team) in the dual matches, all on the same level. (Junior varsity or varsity).

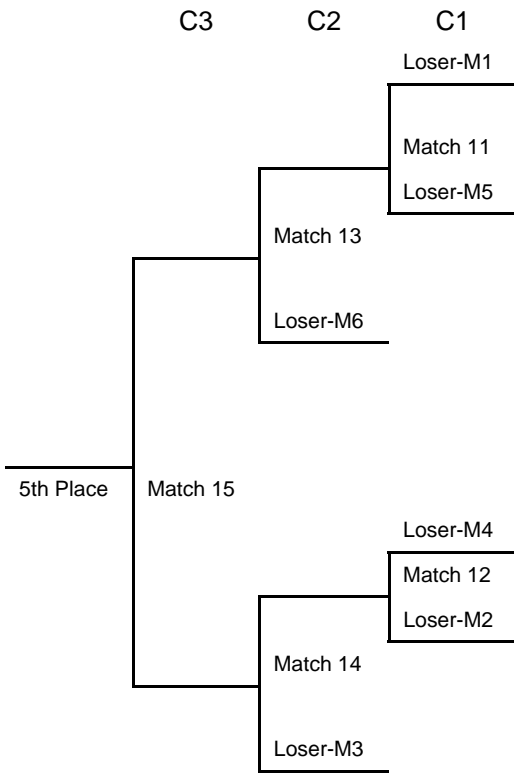
There are no restrictions for third DOUBLES.

## **CONFERENCE BOYS TRACK AND FIELD SPECIFIC RULES**

### **Section 13 - Conference Meet**

The date of the annual boys conference Track and Field meet shall be held on the week before the Illinois High School Association Sectional meet.

A player (contestant) in girl's Track and Field may not compete against a single school on more than one level of competition per conference scheduling period.

### **Section 8 – Starting Times**

The recommended starting time is 04:30 pm for all girls' conference Track and Field dual meet competition.

### **Section 9 - Championships**

The champion named in girl's varsity Track and Field will be the school that totals the most points at the Conference Track and Field meet.

In case of any ties, co-champions are recognized.

### **Section 10 – Team Awards**

A plaque will be awarded every year to the team champions or co-champions at the varsity level according results of the Conference meet.

### **Section 11 – Individual Awards**

Individual medals shall be given to the first, second, and third place winners in each varsity event.

Ribbons shall be given to the fourth, fifth, and sixth place winners in each varsity event.

Ribbons shall be given to the fourth, fifth and sixth place winners in each junior varsity event.

### **Section 12 – Special Post Season Conference Awards**

Excellence in girl's Track and Field will be recognized with the selection of a Player of the Year and a Coach of the year.

The criteria for the selection of the Player of the Year for girl's Track and Field will follow this process. At the coach's seed meeting for the East Suburban Catholic Conference girl's Track and Field Championship meet, each coach will nominate one athlete from their team to be considered as the Athlete of the Year. Coaches will turn in their vote to the meet

administrator by the end of the East Suburban Catholic Conference meet. Although the award will be titled Athlete of the Year, the coaches will actually be selecting an athlete of the meet.

The criteria for the selection of the Coach of the Year for girl's Track and Field will follow this process. Each varsity girl's Track and Field head coach will also list the name of his selection for the Coach of the Year. This name will be submitted along with the ballot for the girl's Player of the Year.

A specially designed Conference Certificate of Honor will be presented to the Player of the Year and Coach of the Year in girl's Track and Field.

### **Section 11 - Championships**

Championships in freshman, junior varsity, and varsity boys Volleyball will be determined on a percentage basis. In the event of a tie, co-championships will be recognized.

A team that does not play a full Conference schedule will not be considered for the championship.

### **Section 12 –Team Awards**

A plaque will be awarded every year to the team champions or co-champions at the varsity level according to the results of the Conference dual meet standings.

### **Section 13 - All-Conference**

An all-conference squad will be selected in boys Volleyball by vote of the head coaches of each member school. The number in boys Volleyball will be twenty-one (21).

Certificates of Honor will be presented to an All-Conference team, as determined by the vote of the coaches of all member schools participating in boys Volleyball.

Certificates will be prepared and awarded to the schools by the secretary. The number of certificates awarded for boys Volleyball shall be determined by the Athletic Directors and has been set at twenty-one (21).

Selection of All-Conference players will be done at the special meeting held immediately after the championship is determined.

In the event there is a need to send a substitute, it is expected that the head coach will prepare the designee with necessary agenda and information so that each school will be represented in a positive manner.

The girls Volleyball All Conference and post season meeting will be held on Sunday, October 22, 2017.

Contacts for this meeting are to be made by the Conference Secretary.

The meeting will be held at St Patrick High School and begin at 10:00 a.m.

For coaches (or representative) missing this meeting: first year probation status; second year: no all-conference selections.

#### **Section 5 – Results And Statistics**

The East Suburban Catholic Conference has designated Kevin Kelly (Marian Catholic) as the Conference Statistician.

Official team standings and game results will be kept in girls Volleyball for the freshman, sophomore, and varsity levels of competition.

Team standings and game results will be posted on the East Suburban Catholic Conference website and will be updated as results become available through the Conference Statistician.

It is the responsibility of each head coach at the freshman, sophomore, and varsity level to FAX or email each game result to the Conference Statistician at the conclusion of each contested event.

Special forms have been prepared for the reporting of results to the Conference Statistician. They can be found on the East Suburban Catholic Conference website.

Results should be FAX or emailed immediately. If a contest has been cancelled or rescheduled, it is the responsibility of each head coach at the freshman, sophomore, and varsity level to identify that information to the Conference Statistician.

### **CONFERENCE GIRLS VOLLEYBALL ADMINISTRATION**

#### **Section 6 – Scheduling**

Scheduling of girls Volleyball will be done by the Athletic Directors or their designees.



The Chairperson of the East Suburban Catholic Conference Athletic Directors will prepare a Master Contract that will contain all conference schedules for the succeeding year.

The Master Contract will be signed by the Principal and Athletic Director of each member school at the May Board of Control Meeting.

There will be a round robin schedule for the freshman, sophomore, and varsity teams.

### **Section 7 - Eligibility**

The Rules of Eligibility of the Illinois High School Association shall apply.

Freshman level competition in girls Volleyball shall be limited to students in their first two semesters after entering the ninth (9<sup>th</sup>) grade.

Sophomore level competition in girls Volleyball shall be limited to students in their first four semesters after entering the ninth (9<sup>th</sup>) grade.

Varsity level competition in girls Volleyball may include students in the freshman, sophomore, junior, or senior years of school unless individual operating procedures designate otherwise.

A player (contestant) in girls Volleyball may not compete against a single school on more than one level of competition per conference scheduling period.

### **Section 8 - Starting Times**

The recommended starting time is 05:00 pm for all freshman and sophomore girls Volleyball competition.

The recommended starting time is 06:00 pm for all varsity girls Volleyball competition.

### **Section 9 - Officials**

Two Illinois High School Association officials are to be contracted for a varsity girls Volleyball contest.

Two Illinois High School Association officials are to be contracted for the freshman and sophomore girls Volleyball contests.

### **Section 10 - School Information**

All Conference schools shall furnish the following information to the other schools at least one week prior to their scheduled varsity game.

- Names of varsity coaches,
- School colors;

- Weight.

Any changes in players' numbers that may occur after the original roster (s) has been supplied should be corrected by the head coach to the opposing head coach and to the announcer prior to the start of the contest.

## **CONFERENCE GIRLS VOLLEYBALL HONORS**

### **Section 11 - Championships**

Championships in freshman, sophomore, and varsity girls Volleyball will be determined on a percentage basis. In the event of a tie, co-championships will be recognized.

A team that does not play a full Conference schedule will not be considered for the championship.

### **Section 12 – Team Awards**

A plaque will be awarded every year to the team champions or co-champions at the varsity level according to the results of the Conference dual meet standings.

### **Section 13 - All-Conference**

An all-conference squad will be selected in girls Volleyball by vote of the head coaches of each member school. The number in girls Volleyball will be **eighteen (18)**.

Certificates of Honor will be presented to an All-Conference team, as determined by the vote of the coaches of all member schools participating in girls Volleyball.

Certificates will be prepared and awarded to the schools by the secretary. The number of certificates awarded for girls Volleyball shall be determined by the Athletic Directors and has been set at **eighteen (18)**.

Selection of All-Conference players will be done at the special meeting held immediately after the championship is determined.

The girls Volleyball meeting is scheduled for Sunday, October 22, 2017.

Contacts for this meeting are to be made by the Conference Secretary.

The meeting will be held at St Patrick High School and begin at 10:00 a.m.

The Conference Secretary is responsible to publish the girls Volleyball All Conference team.

There will be a copy of the girls Volleyball All Conference team published on the East Suburban Catholic Conference website.

The Conference does not recognize Honorable Mention teams and will not publish or recognize any such selections.

### **Section 14 – Special Post Season Conference Awards**

Excellence in girls Volleyball will be recognized with the selection of a Player of the Year and a Coach of the Year.

The Most Valuable Player of the conference in girls Volleyball will be the individual that receives the highest number of votes in the balloting for All Conference.

The Coach of the Year of the Conference in girls Volleyball will be the individual that receives the highest number of votes after nomination.

A specially designed Conference Certificate of Honor will be presented to the Player of the Year and Coach of the Year in girls Volleyball.

## **CONFERENCE GIRLS VOLLEYBALL SPECIFIC RULES**

### **Section 15 - Game Ball**

The official Conference volleyball will follow the State or Illinois High School Association regulations.

The host school at all levels of girls Volleyball will be responsible for supplying volleyballs to visiting schools for all warm up periods.

The host team at all levels shall provide the visiting team with a chalkboard or grease board with appropriate writing implements.

The boys Wrestling post season meeting is scheduled for **Tuesday, March 6, 2018 (tentative)**.

#### **Section 5 – Conference Meet Results**

The East Suburban Catholic Conference has designated Kevin Kelly (Marian Catholic) as the Conference Statistician.

Official Conference Meet results will be kept in boys Wrestling for the freshman, junior varsity and varsity levels of competition.

Final team standings and Conference Meet results will be posted on the East Suburban Catholic Conference website.

The host school for the Conference Meet in boys Wrestling will be responsible to provide results of the varsity, junior varsity and freshman levels to the league statistician/ webmaster and provide results to the media (varsity level).

Conference Meet results should be made available to the website host at the conclusion of the competition and those results will be posted on the East Suburban Catholic Conference website.

There is a particular presentation format for the results of the freshman, junior varsity and varsity levels of competition for boys Wrestling.

## **CONFERENCE BOYS WRESTLING ADMINISTRATION**

### **Section 6 – Scheduling**

Scheduling of boys Wrestling will be done by the Athletic Directors or their designees.

The Chairperson of the East Suburban Catholic Conference Athletic Directors will prepare a Master Contract that will contain all conference schedules for the succeeding year. The Master Contract will be signed by the Principal and Athletic Director of each member school at the May Board of Control Meeting.

The member schools of the East Suburban Catholic Conference will compete in a Mega Dual concept vs. three or four teams at one site in January on the varsity, junior varsity and freshmen levels. Matchups will be determined based on standings from the ESCC tournament the previous year.

Mega dual wrestling competition within the East Suburban Catholic Conference will begin at 9 a.m. with an 8 a.m. weigh-in.

Travel distance should be a consideration when scheduling Mega Duals.

A level of competition should be assigned to a particular mat. Each mat should run continuous dual meets until that level is completed. Adequate warm up time should be allowed between dual meets.

If a level finishes early, matches from another mat and level may be moved to the mat that has finished its level. Protocol dictates that both involved coaches agree to this move or the move should not be pressed.

### **Section 7 - Eligibility**

The Rules of Eligibility of the Illinois High School Association shall apply.

Freshman level competition in boys Wrestling shall be limited to students in their first two semesters after entering the ninth (9<sup>th</sup>) grade.

Junior Varsity level competition in boys Wrestling shall be limited to students in their first six semesters after entering the ninth (10<sup>th</sup>) grade.

Varsity level competition in boys Wrestling may include students in the freshman, sophomore, junior, or senior years of school unless individual operating procedures designate otherwise.

No contestant shall compete on more than one level per conference scheduling period.

A wrestler may only compete on one level of competition in the Conference tournament.

A wrestler may only compete on one level against one school during dual meet competition. A wrestler may wrestle two different levels against different schools during double dual competition.

### **Section 8 - Starting Times**

The recommended starting time is 9 a.m. for all freshman, junior varsity and varsity Wrestling competition using the Mega Dual format.

### **Section 9 - Officials**

The East Suburban Catholic Conference will employ an officials' assignment chairman who will be responsible for assigning officials for double dual competition and for the conference tournaments.

Assignments are to be made for officials designated for certain levels of competition officiating.

Conference wrestling coaches are responsible for forwarding a composite listing of acceptable officials for their own school to be used in assignment of their meets.

The assignment chairman will make Officials Evaluation Forms available for conference coaches for the purpose of rating and evaluating assigned officials.

One Illinois High School Association official is to be contracted for a varsity boys Wrestling contest.

One Illinois High School Association official is to be contracted for a junior varsity boys Wrestling contest.

One Illinois High School Association official is to be contracted for a freshman boys Wrestling contest.

## **CONFERENCE BOYS WRESTLING HONORS**

### **Section 10 - Championships**

The freshman, junior varsity, and varsity championships shall be determined by the points awarded according to the teams' finishes in the Conference meet.

### **Section 11 – Team Awards**

A plaque will be awarded every year to the team champion or co-champion at the varsity level according to the results of the Conference dual meet standings and the results of the Conference meet.

### **Section 12 – Individual Awards**

Individual medals shall be awarded to the first three placers in each weight class at the freshman, junior varsity, and varsity levels.

An award will be given to the Most Valuable Wrestler at the East Suburban Catholic Conference Tournament. The head coaches at the championship meet will vote this award on.

### **Section 13 – Special Post Season Conference Awards**

Excellence in boys Wrestling will be recognized with the selection of a Player of the Year and a Coach of the Year.

The criteria for the selection of the Player of the Year and the Coach of the Year will be developed by the boys Wrestling coaches of the Conference.

The Most Valuable Player of the conference in boys Wrestling will be the individual that receives the highest number of votes in the balloting for All Conference.

A specially designed Conference Certificate of Honor will be presented to the Player of the Year and Coach of the Year in boys Wrestling.

## **CONFERENCE BOYS WRESTLING SPECIFIC RULES**

### **Section 14 - Conference Tournament**

The East Suburban Catholic Conference will conduct individual conference wrestling tournaments at the freshman, junior varsity, and varsity levels. The tournaments will be conducted one week prior to the Illinois High School Association Regional Tournament.

The place and time of the Conference meet will be determined by agreement of the Athletic Directors each year and the designated hosts of the Conference meets will be responsible for conducting the tournaments.

The weight classes, format, and scoring for the varsity and junior varsity level tournament will be the same as the Illinois High School Association for the current year. Wrestling will take place in the following weight classes:

106 Pounds - 113 Pounds - 120 Pounds - 126 Pounds –  
132 Pounds - 138 Pounds - 145 Pounds - 152 Pounds –  
160 Pounds - 170 Pounds - 182 Pounds - 195 Pounds –

The weight classes, format, and scoring for the junior varsity level tournament will be identical to the varsity tournament with the exception that there be a wrestle back round to fifth place. The freshman and junior varsity East Suburban Catholic Conference will wrestle back to fifth place during their conference tournaments. The wrestle back should take place from the semifinalists with cross-bracketing occurring. There should be automatic advancements (walk over). Scoring will take place to sixth place. Awards will be given to third place. Wrestling will take place in the following weight classes:

The wrestle back should take place from the semifinalists with cross-bracketing occurring. There should be automatic advancements (walk over). Scoring will take place to sixth place. Awards will be given to third place. Wrestling will take place in the following weight classes:

The varsity Conference tournament will be wrestled on a Friday, one week prior to the Illinois High School Association Regional Tournament. The varsity Conference tournament will be scheduled to start at 03:30 pm. Weigh-in time will be designated from 01:30 pm through 03:00 pm. Scratch meetings will be held (as necessary) during the time between the weigh-in and the designated starting time.

The junior varsity Conference tournament will be wrestled on a Saturday, one week prior to the Illinois High School Association Regional Tournament. The junior varsity Conference tournament will be scheduled to start at 09:00 am. Weigh-in time will be designated from 07:00 am through 08:30 am. Scratch meetings will be held (as necessary) during the time between the weigh-in and the designated starting time.

The freshman Conference tournament will be wrestled on a Saturday, one week prior to the Illinois High School Association Regional Tournament. The freshman Conference tournament will be scheduled to start at 09:00 am. Weigh-in time will be designated from 07:00 am through 08:30 am. Scratch meetings will be held (as necessary) during the time between the weigh-in and the designated starting time.

Meetings will be conducted on the Wednesday prior to the conference tournament to seed the freshman, junior varsity, and varsity level tournaments. The seeding meetings will be conducted at the centrally located Notre Dame High School in Niles, Illinois, and will begin at 07:00 pm. A general meeting should be conducted to discuss tournament procedure and to answer pertinent questions. Three meeting areas should be designated for freshman, junior varsity, and varsity level coaches to convene and to seed the three level tournaments.

An award will be presented to the student-athlete named the "Outstanding Wrestler of the East Suburban Catholic Conference Varsity Wrestling Tournament." The student-athlete will be selected by vote of the varsity coaches at the varsity conference meet. Each coach will vote for three individuals. The first listed position is worth three (03) points, the second listed position is worth two (02) points, and the third listed position is worth one (01) point. The "Outstanding Wrestler of the East Suburban Catholic Conference Varsity Wrestling Tournament" will be named from this voting process.

Each Conference school will be responsible for a forty-dollar (\$40.00) entry fee to the host school of each level of the East Suburban Catholic Conference Wrestling Tournaments.

### **Section 15 - Conference Tournament Criteria**

#### **EAST SUBURBAN CATHOLIC CONFERENCE SEEDING CRITERIA FOR WRESTLING**

#### **ILLINOIS HIGH SCHOOL ASSOCIATION SEEDING CRITERIA**

1. Record versus common opponents (including head-to-head)
2. Returning champion or runner up in the same weight class
3. Quality of competition
4. Season record
5. Vote of coaches who have wrestlers in the same weight class

#### **EAST SUBURBAN CATHOLIC CONFERENCE SEEDING CRITERIA FOR WRESTLING**

1. Conference record which includes head to head competition (This will be matches contested in the Mega Duals)
2. Season record (Overall record)
3. Record versus common opponents
4. Returning champion or runner up in the same weight class as last year
5. Vote of coaches who have wrestlers in that weight class

(Obviously #04 does not fit the freshman level and might not fit the junior varsity level)

When figuring a wrestler's record, it should be done at the weight class that he is going to enter. A wrestler's overall record is every match he has wrestled. It should be understood that when a wrestler comes down in weight class (say from 112 pounds to 103 pounds), his record should also come down with him. However, the converse is not true for a wrestler going up a weight class (say from 112 pounds to 119 pounds). The record at 112 pounds does not go up.

**A WRESTLER IS ENTERED IN THE CONFERENCE WRESTLING TOURNAMENT AT ANY ONE OF THE THREE LEVELS WHEN THAT INDIVIDUAL MEETS THE SCALE REQUIREMENTS AT THE WEIGH IN.**
